From Our Delegate - Manuscript Update

Last May GSO initiated a lawsuit to stop the sale of “printer's copy” of an Original Manuscript of the Big Book. Lois gave this draft to a close friend/member who bequeathed the manuscript to AAWS upon his death but it was never received. We discussed this topic in depth at a special workshop at the October 2017 Assembly. Subsequently, our legal counsel recently filed a motion to dismiss the suit. There have been several motions, stipulations, due dates, etc.

JUST IN! *Paraphrasing a letter to the court on the manuscript litigation:* parties are trying to settle the matter without further court intervention & asks the Judge to adjourn the motion again. What can happen in a situation like this is that a settlement is reached and the next public court filing is simply a bare bones stipulation stating that the action was settled without any details of the settlement.
