OFFICER REPORTS

Secretary: Nanette L.- Good morning, Area 14! My name is Nanette L., and I am an alcoholic. I am happy to serve as secretary for Area 14 and Panel 73. Let me begin by thanking all those that have helped me fulfill my position on the Panel, especially our proofreaders and technology specialists. Our Webmaster uploaded the April 2023 motions to our NFAC password-protected website on April 21, 2023. Alex M. uploaded the digital version of the minutes to the password-protected area on our website on June 1, 2023. Our Webmaster e-mailed the April 2023 minutes to the body on June 7, 2023. The printed minutes were mailed to one address on June 8, 2023. Please let me know if you have yet to receive your minutes or have questions about the April minutes. This weekend, fifty printed copies of our April Assembly minutes were available at the registration desk. According to passed motions, a revised version of Structure and Guidelines can be found on our website. I am presently working on corrections and passed motions to our Advisory Actions posted on the NFAC website. Thank you again for allowing me to serve. **From the Chair- Are there any other changes to the April 2023 minutes? Seeing none. Motion to accept the minutes. Passed.**

Treasurer: Bryant G. – Good Morning, my name is Bryant G., and I am alcoholic. My home group is the Baymeadows Group in District 30. It is an honor and a privilege to serve as your Panel 73 Treasurer. Will the Host District please pass the basket? In keeping with our Tradition of only accepting contributions from A.A. members and entities, it's helpful to include four things with your contribution: your groups' number, groups' name, district number and contact information. This will ensure that Groups Contributions are correctly inputted. I have available the current Treasurer's P.O. Box address to help with directing contributions. This will help lower the number of contributions being sent to the wrong address. We've received a few calls and emails about misdirected contributions. The current state of the Area financially is sound. We have brought in \$36,701.32 of income, which includes \$7,871.22 in Online Contributions. We have had \$47,633.30 in expenses, giving a net of \$8,873.51 above expenses. Our Prudent Reserve currently is \$17,499 below the 12-month maximum allowed. We do have a combined \$100,440.65 in

I have been delighted to serve as our Area 14 delegate since we last gathered for Assembly. Spring is conference season, and it was an amazing experience I will never forget and always be grateful for. As your Delegate and as the 74th GSC Delegate Chair, I am working hard to keep communication open between the 93 Area Delegates of the US/Canada Service structure, The Board of Trustees, and all of us. As directed by an advisory action from the 73rd GSC, we will meet as a full conference after each Quarterly Board meeting to continue this commitment to transparency and communication. Many of you attended post-conference workshops held over the past weeks, and yesterday, I presented a post-conference report back here. I have brought to you the results of the collaboration and consideration for the agenda items from the 73rd General Service Conference. I have shared a few fun pictures and told some fun stories too. This morning, I would like to share for a minute about something else that happened at the Conference. Something not tangible but incredibly powerful. When the 93 Area Delegates in the US Canada service structure come together, along with the Trustees, Directors, and some staff from GSO, the love, respect, and dedication for the fellowship of Alcoholics Anonymous is unmistakable. I call this the spirituality of the Conference. When my PI committee met to discuss the agenda items we were tasked with, we brought to the table the voices of our various areas along with a variety of experiences, sobriety, beliefs, opinions, and knowledge. We seldom began the discussion in complete agreement, but we listened to each other. We learned from each other and developed an informed group conscience that led to every vote we took on each agenda item being passed or failed unanimously. The entire Conference meets beginning on Wednesday to consider the resulting recommendations and considerations by the committees and for the approval of the Trustees and Directors. This Conference had its moments of hilarity, like when the GM Bob W. raised his foot to the podium and showed us his socks every morning; they are legendary. Or when the South Florida delegate and I were running around trying to find pizza to avoid another meal of "chicken again!" And then there were moments sublime filled with the unmistakable presence of a power greater than ourselves working through us. We then had a lively sharing session about the Accessibilities checklist worksheet and the importance of communicating our level of accessibility at the group level to our local intergroup offices so that Where and When meeting schedules and the Meeting Guide app have accurate information for people in need. Next, we heard from members of District 15 about the collaborative work they've been able to achieve between committee chairs through their H&I committee. We ended our time with a discussion of two agenda items that will be introduced today. That is all. Thank you for letting me serve.

Cooperation with the Professional Community- Harry D.- Public Information- Talitha- combined workshop and report - Good morning. I am Harry D., alcoholic. I am privileged to serve as your Panel 73 Cooperation with the Professional Community Chairperson. And I am Talitha C., alcoholic. I am privileged to serve as your Panel 73 Public Information Chairperson. On Saturday, July 8, 2023, we got to present at the 10:00 a.m. combined CPC/PI Workshop in the Coronado Room at the Mission Inn Resort & Club. Together in Service, we offered an extra special thanks of Gratitude to Justus, our Area 14 Technology Service Coordinator, who had the technical equipment in the room set up, tested, and confirmed that our light show would not impact our neighbor workshop rooms. Thank you! We had a total of 44 members who signed in and others who joined during the presentation. The attendees represented at least 27 of our 33 Area 14 districts. Thank you to all who attended! The workshop opened with the Serenity Prayer. The agenda featured a deck of topics that included an overview of CPC and PI, local and national conferences, best practices in general and examples specific to the Districts, a "script" to use to help talk about AA or to share with others, helpful resources to use when preparing for a talk, technology to connect the public to AA information, like a QR Code that links to the GSO page or the "Meeting Finder" App, service project action ideas, and how to get started with a call to action in your District. So far this year, we have staffed two conferences, one local and one sponsored by GSO. And we have two more coming up with Full Sail University and the Florida Conference of County Judges. And the year is barely half-over. So, we are looking for many more opportunities, with this body's help, to make Alcoholics Anonymous – Anonymous but not Invisible in North Florida. We devoted almost half of our workshop to inspiring our members to answer the "Call to Action" in their districts. Members wrote down on a piece of paper names of groups, organizations, and agencies in their districts that they had a passion to target and carry the message of hope to their communities. Using a "hard" hat, because we are in the business of building relationships, we identified potential targets from the passions shared on paper. We then

Good morning, my name is Nicole, and I am an alcoholic. I have a sobriety date of May 4, 2015. My home group is The Back Porch International and I currently serve as your North Florida Corrections Chair. I had the honor and privilege to serve with Debra V. who has a sobriety date of September 10, 1988. Her home group is the Fiesta Group, and she currently serves as your North Florida Intergroup Chair. Yesterday morning, we met for our first ever Corrections and Intergroup workshop for Panel 73. There were 80 attendees present. We reviewed a current experience that involved North Florida Intergroup and Corrections and how the two entities were able to come to an understanding after much resistance. We talked about Concept 9 and looked to Bill's letter on leadership to guide us. Bill talks about leaders driving by example, not mandate, and we stressed that love and tolerance of others is our code. We discussed Tradition 2 and our leaders not governing. We had a loving discussion around sticking to the Traditions while entering correctional facilities and some of the issues that we have been able to navigate through using the Traditions as a tool. Thank you for giving Debra and I the opportunity to participate in our recovery and serve the North Florida region of Alcoholics Anonymous.

Grapevine/LaVina- Donald Mc- There were 22 people in attendance for the workshop. We discussed: What the Grapevine is., Why groups and individuals buy subscriptions to the Grapevine, the types of subscriptions, the AA Grapevine podcast, and the AA Grapevine YouTube page. For book sales, we sold fourteen books and CDs for a total of \$177.00.

We had about 30 total attendees, with a lot of participation from everyone. We discussed the current bids and have only 2 viable options. There was lots of discussion about our looks at unconventional locations like retreat centers and colleges. It was decided they don't meet our needs because of handicap accessibility, food restrictions, room availability, etc. A motion to accept the bid from the Westin in Lake Mary for 2025/2026 was made, seconded, and voted in unanimously and will be brought to the floor during new business. We had a very lively discussion regarding the future of our assembly and how we conduct business. It seems to be getting more difficult to find locations that meet our needs physically and financially and are willing to do business with us. Are we keeping people from participating because of rising costs? Some suggestions were 1-day assemblies, biannual instead of quarterly, and hybrid. It was suggested we develop a questionnaire for the fellowship on their needs and concerns. We could also review the responses to the Area 14 Inventory 2023 for ideas. We will be working on that in the near future. The best part of our discussion was a “first-timer” commenting on how he learned more this weekend from talking and asking questions from people in the hallway than the meetings, and people would miss out on that if we went away from a full weekend assembly.

How the Conference Operates

Generally speaking, the General Service Conference follows *Robert's Rules of Order*, and proceeds on an informal basis as possible consistent with the rights of all concerned. It is important to remember that the purpose of rules of order is to make it easier for the Conference to conduct its business; rules exist to allow the Conference to do what it needs to do to carry out the will of the Fellowship by reaching an informed group conscience. Over the years the Conference has adopted some exceptions to *Robert's Rules*, which help it to proceed more closely in accord with the spirit of A.A. Tradition.

Conference Quorum

A Conference quorum — two-thirds of all registered members — is required to conduct Conference business.

Committee System

To the extent possible, important matters to come before the Conference will be handled via the "Committee system." This assures that a large number of questions can be dealt with during Conference week. Members are encouraged to trust the process. Each Committee has considered carefully the items before it and presents its recommendations to the Conference as a whole for acceptance or rejection. Recommendations of Conference committees are automatically motions that have been made and seconded. Members are asked to refrain from spontaneously amending the work of the Committee; there are no "friendly" amendments under Robert's Rules.

Substantial Unanimity

All matters of policy (Conference Advisory Actions) require substantial unanimity, that is, a *two-thirds majority*. Any actions, including amendments, that affect an Advisory Action, or motions that might result in such an action, also require a *two-thirds majority*. Because the number of members present in the hall during the week of Conference varies from time to time, the phrase "two-thirds majority" is taken to mean two-thirds vote of the Conference members voting, as long as the total vote constitutes a Conference quorum.

Minority Opinion

After each vote on a matter of policy, the side which did not prevail will always be given an opportunity to speak to their position. If the motion passes with two-thirds vote, the minority may speak. If the motion receives a majority vote, but fails to pass for lack of a two-thirds vote, the majority may speak.

Remember that saving "minority opinions" for after the vote, when there is no rebuttal, is a time-waster, for it can force the Conference body to reconsider a question that might well have been decided the first time around if it had been thoroughly examined from all sides.

General Rules of Debate and Voting

(Agreed to at the beginning of each Conference)

- People who wish to speak line up at the microphones and address their comments to the chair.
- Each person may speak for two (2) minutes.
- No one may speak for a second time on a topic until all who wish to have spoken for the first time.
- *Full* discussion of a recommendation should take place *before* each vote.
- Everyone is entitled to express his or her opinion. However, if your perspective has already been stated by someone else, it is not necessary to go to the mike and say it again.
- Our experience is that premature actions such as amend-

ing motions early in the discussion or hastily calling the question can divert attention from the subject at hand, confusing and/or delaying Conference business.

Motions Made During Conference

When making a motion, come to the microphone and address the chair. There are various types of motions we use to help reach an informed group conscience. The specific rules governing each are on the next page.

Tabling a Motion

Tabling a motion postpones discussion to a later time during the same Conference.

Motion to Recommit

The motion to recommit returns a motion or proposal to the respective trustees' committee or appropriate corporate board for further consideration. A motion to recommit must be seconded, is debatable and can be amended.

Calling the Question


Calling the question brings debate to a halt while Conference members decide whether to proceed directly to a vote (the question) or go on with the debate.

Reconsideration

A motion to reconsider a vote may be made only by a member who voted with the prevailing side, but it can be seconded by anyone. If the majority votes to reconsider, full debate, pro and cons, is resumed.

Floor Actions

It is possible for a Conference action to come from the floor, but any matter which falls within the scope of a Conference committee ought first go through that Conference committee, so that the topic may receive due consideration. Floor actions may be introduced at any time during the Conference except at the Sharing Sessions. Any floor action regarding a piece of committee business that has not yet been concluded will be considered out of order. When a floor action is to be heard, its maker will be given two (2) minutes to state the rationale behind the action, after which the chair shall ask if there is a motion that the Conference decline to consider the floor action.



Declining to Consider a Floor Action

A motion to decline to consider a floor action is made without comment.

- Motions must be made in order at the microphone.
- Address motions to the chair.
